GREAT CANADIAN'S HASTINGS RACECOURSE OPENS PHASE I SLOT OPERATIONS ON SATURDAY NOVEMBER 10, 2007

November 12, 2007 – Richmond, BC – Great Canadian Gaming Corporation [TSX:GC] (the “Company”) announced today that the first phase of its redevelopment of Hastings Racecourse in Vancouver, British Columbia (“Hastings”) featuring the initial 150 slot machines at the property, opened to the general public on Saturday November 10, 2007. The hours of operation for the slot machine facility are from 9 am to 2 am Sunday through Thursday and 24 hours on Fridays and Saturdays.
